## ElanOre Resources sends spodumene concentrate sample to Fancy Mining Industry Co., Ltd.

Toronto - <u>Jourdan Resources Inc.</u> (TSX-V: JOR) (&#8220; JOURDAN&#8221; or the &#8220; Company&#8221;) (www.jourdan.ca) is pleased to announce ElanOre Resources Inc. (&#8220; ElanOre&#8221;), a Canadian private company in which Jourdan holds 6 million shares (24.9%) has shipped a concentrate sample to Fancy Mining Industry Co., Ltd (&#8220; Fancy&#8221;) for testing.

If Fancy reports positive test results and supply can be secured, orders of 150,000 tonnes of spodumene concentrate are expected to be traded as part of the agreement between ElanOre and Fancy.
