A comprehensive contingency plan is in place and the company expects operations to continue and production guidance to be maintained. The striking workers represent about 12% of Hudbay's 1460 person Manitoba workforce.

Hudbay sought a mutually negotiated agreement over several months and does not believe the strike action is necessary. Hudbay remains committed to the bargaining process and hopes the union leadership will engage in good faith negotiations.
