OAKVILLE, Ontario, Feb. 06, 2018 (GLOBE NEWSWIRE) -- [Saint Jean Carbon Inc.](#) ("Saint Jean" or the "Company") (TSX-V: SJL) wishes to announce that it has received interest from investors in excess of the 10,000,000 units ("Common Units") priced at \$0.05 per Common Unit for gross proceeds to the Company of up to \$500,000 (the "Offering") previously announced on January 17, 2018. Subject to regulatory approval, the Company intends to increase the maximum amount of the Offering by 100,000 Common Units to 10,100,000 Common Units for gross proceeds of up to \$505,000. The Company intends to close the second and final tranche of the Offering on or about February 8, 2018.

Each Common Unit will consist of one (1) common share in the capital of the Company and one (1) common share purchase warrant (each a "Warrant"). Each Warrant will entitle the holder to acquire one (1) additional common share in the capital of the Company (each a "Warrant Share") at an exercise price of \$0.05 per Warrant Share for a period of 36 months from the date of issuance.

All securities issued as part of the Offering are subject to a four month and one (1) day hold period.
