## Teras Resources Inc. Announces Increase to and Closing of Unit Private Placement

Calgary, March 5, 2020 - Teras Resources Inc. (TSXV: TRA) ("Teras" or the "Company") announces that it has increased the size of its previously announced non-brokered private placement of units (each a "Unit"). In addition, Teras announces that it has completed the closing of the private placement of Units, subject to final approval of the TSX Venture Exchange. Teras issued 10,232,380 Units at a price of \$0.05 per Unit for gross proceeds of \$511,619. Each Unit consists of one common share (a "Common Share") and one Common Share purchase warrant (a "Warrant"). Each Warrant is exercisable into one Common Share at a price of \$0.075 per share for a period of two years from the issuance of such Warrant. In addition, Teras issued 399,000 Broker warrants at a price of \$0.075 for a period of one year and paid a finder's fee of \$19,950 cdn.

The majority of proceeds from the private placement will be reserved for positioning the Company for the next steps moving forward. The Company will provide an update to its shareholders in the near future as disclosed in the January 23rd, 2020 news release. One of the Company's senior Officers subscribed to 2,000,000 units of the Placement. All securities issued in connection with the private placement are subject to a hold period that expires on July 05, 2020.

Subject to the approval of the TSX Venture Exchange, the Company has extended the dates of Warrants set to expire on April 17<sup>th</sup>, 2020 until April 17<sup>th</sup>, 2021 as well as Warrants set to expire August 01, 2020 until August 01, 2022.

## **About Teras**

Teras is focused on developing its Cahuilla project located in Imperial County, California. The project encompasses an area of at least 3 km by 1.5 km and Teras believes that the Cahuilla project has the potential to develop into a mining operation consisting of altered and mineralized sedimentary host rocks with numerous sheeted high-grade sheeted quartz veins. Teras filed a NI 43-101 technical report with an indicated resource of 1.0 million ounces of gold and 11.9 million ounces of silver on its Cahuilla project (70 million tons at an average grade of 0.015 ounces per ton gold and 0.17 ounces per ton silver with a cut-off of 0.008 ounces per ton gold) and inferred class of 10 million tons grading 0.011 opt gold and 0.10 opt silver. Gold equivalent ounces are 1.2 million ounces in indicated class and 130,000 ounces in inferred class using a ratio of 55 silver ounces to 1 gold ounce. For further information on the Cahuilla project refer to the NI 43-101 technical report entitled "Cahuilla Property 43-101 Technical Report," filed with Sedar on November 27, 2012.
