## Skyharbour Announces and Closes \$1.68 Million Private Placement

VANCOUVER, April 30, 2020 - <u>Skyharbour Resources Ltd.</u> (TSX-V: SYH) (OTCQB: SYHBF) (Frankfurt: SC1P) (the &#8220;Company&#8221;) is pleased to announce it has arranged and closed a non-brokered private placement financing for total gross proceeds of CAD \$1,678,799.86 (the &#8220;Private Placement&#8221;). The bulk of the financing was subscribed for by strategic and institutional investors.

The Company has allotted and issued 5,358,666 units (the "Units") at a price of CAD \$0.15 per Unit and 4,861,111 flow-through units (the "FT Units") at a price of CAD \$0.18 per FT Unit. Each Unit is comprised of one common share and one warrant ("Warrant"). Each FT Unit is comprised of one flow-through common share and one Warrant. Each Warrant will entitle the holder to purchase one additional common share for a period of three (3) years at a price of CAD \$0.22 per share.

In addition, the Company has paid finder's fees totaling \$63,858 and issued an aggregate 335,587 finder's warrants (the "Finders Warrants") to arm's-length parties. Each Finders Warrant is exercisable into one common share for a period of up to three (3) years at a price of CAD \$0.22.

The Company intends to use the proceeds from this Private Placement for exploration and upcoming drilling programs as well as for general working capital purposes. The Private Placement is subject to final TSX Venture Exchange ("Exchange") approval and all securities issued are subject to a four-month-and-one-day hold period.

About Skyharbour Resources Ltd.:

Skyharbour holds an extensive portfolio of uranium and thorium exploration projects in Canada's Athabasca Basin and is well positioned to benefit from improving uranium market fundamentals with six drill-ready projects. Skyharbour has acquired from Denison Mines, a large strategic shareholder of the Company, a 100% interest in the Moore Uranium Project which is located 15 kilometres east of Denison's Wheeler River project and 39 kilometres south of Cameco's McArthur River uranium mine. Moore is an advanced stage uranium exploration property with high grade uranium mineralization at the Maverick Zone with drill results returning up to 6.0% U<sub>3</sub>O<sub>8</sub> over 5.9 metres including 20.8% U<sub>3</sub>O<sub>8</sub> over 1.5 metres at a vertical depth of 265 metres. Skyharbour has signed option agreements with Orano Canada Inc. and Azincourt Energy whereby Orano and Azincourt can earn in up to 70% of the Preston Project through a combined \$9,800,000 in total exploration expenditures, as well as \$1,700,000 in total cash payments and Azincourt shares. Preston is a large, geologically prospective property proximal to Fission Uranium's Triple R deposit as well as NexGen Energy's Arrow deposit. The Company also owns a 100% interest in the Falcon Point Uranium Project on the eastern perimeter of the Basin which contains a NI 43-101 inferred resource totaling 7.0 million pounds of U3 O<sub>8</sub> at 0.03% and 5.3 million pounds of ThO<sub>2</sub> at 0.023%. The Company's 100% owned Mann Lake Uranium project on the east side of the Basin is strategically located adjacent to the Mann Lake Joint Venture operated by Cameco, where high-grade uranium mineralization was recently discovered. Skyharbour's goal is to maximize shareholder value through new mineral discoveries, committed long-term partnerships, and the advancement of exploration projects in geopolitically favourable jurisdictions.
