Osisko Metals Announces C\$5 Million Private Placement of Flow-through Shares

MONTREAL, Dec. 02, 2021 - <u>Osisko Metals Inc.</u> (the "Corporation" or "Osisko Metals") (TSX-V:OM; OTCQX: OMZNF; FRANKFURT: OB51) is pleased to announce that it has entered into an agreement with Haywood Securities Inc. ("Haywood") in connection with a "best efforts" private placement of up to 10,417,000 common shares of the Corporation that will qualify as "flow-through shares" (within the meaning of subsection 66 (15) of the *Income Tax Act* (Canada)) ("Flow-Through Shares"), at a price of C\$0.48 per Flow-Through Share (the "Issue Price"), for gross proceeds of up to C\$5,000,160 (the "Offering").

In addition, Haywood has been granted an option to sell up to an additional 2,083,400 Flow-Through Shares at the Issue Price for additional gross proceeds of up to C\$1,000,032, exercisable at any time by Haywood up to 48 hours prior to closing of the Offering.

The gross proceeds from the Offering will be used by the Corporation to incur eligible "Canadian exploration expenses" that will qualify as "flow-through mining expenditures" (as such terms are defined in the *Income Tax Act* (Canada)) (the "Qualifying Expenditures") related to the Corporation's Pine Point Zinc Project, located in the Northwest Territories. All Qualifying Expenditures will be renounced in favour of the subscribers of the Flow-Through Shares effective December 31, 2021.

The Corporation has agreed to pay a cash commission equal to 6.0% of the gross proceeds of the Offering. The Offering is expected to close on or about December 22, 2021 and is subject to certain closing conditions including, but not limited to, the receipt of all necessary approvals including the conditional listing approval of the TSX Venture Exchange and the applicable securities regulatory authorities. The Offering is being made by way of private placement in Canada. The securities issued under the Offering will be subject to a hold period in Canada expiring four months and one day from the closing date of the Offering.

<u>Osisko Metals Inc.</u> is a Canadian exploration and development company creating value in the base metal space. The Corporation controls two of Canada's premier past-producing zinc mining camps: 1) the Pine Point Project that is located in the Northwest Territories, for which the most-recently filed PEA in July 2020 has indicated an after-tax NPV of \$500M and an IRR of 29.6%. The Pine Point Project PEA is based on current Mineral Resource Estimates that are amenable to open pit and shallow underground mining and consist of 12.9Mt grading 6.29% ZnEq of Indicated Mineral Resources and 37.6Mt grading 6.80% ZnEq of Inferred Mineral Resources. The company has optioned the majority of its holding in the Bathurst Camp to Brunswick Exploration, pending TSXV approval for the transaction.
