James Withall, Chief Executive Officer of Rupert Resources said, "Our third annual sustainability report shows how Rupert Resources continues to move forward with purpose in the development of Ikkari. The project has the potential to become a lowest quartile GHG emissions gold mine due to the project's access to 100% renewable power, high open pit gold grade and low strip ratio. Rupert Resources' long-term strategy remains focussed on: (1) discovering deposits of significant scale and quality, characterized by high margins and potential for low environmental impact; (2) ensuring that investments contribute to valuation accretion to maximize returns per share; and (3) developing sustainably and planning for the long term. The Company is now entering the key permitting and development stages for the project and is continuing with its long-term engagement programs to demonstrate the project's benefits to all stakeholders whilst minimising the environmental impacts of the Company's activities.
